

Terms & Conditions

General

1. PCSB refers to Phillip Capital Sdn Bhd.
2. Client refers to PCSB client.
3. Promotion period is from 1 October 2025 to 31 March 2026 (both dates are inclusive).
4. 'BMD' refers to Bursa Malaysia Derivatives.
5. Products refer to BMD FKLI, FCPO, FCNH, FGLD and FKLM

Promotion Mechanism

Part 1: On boarding Bonus: Account Activation Rewards

1. New clients who successfully open a futures trading account during the promotion period and execute at least one lot in a selected BMD product as listed in Table 1 will receive **RM 50 of Cash Trading Credit Bonus**
2. Only the first trade executed within the same calendar month as the account opening will be taken into consideration.
3. The rewards are strictly for new clients who meet all eligibility criteria within the promotion period. Only trades executed online (self-executed) or via call-in are eligible. Cash settlements are excluded.
4. The reward is limited to the **first 50 new clients per month based on account created date (account activation email received)** on a **first-come, first-served basis**.
5. Rewards will be issued to eligible clients on the **25th of the following month** (i.e., November, December, and January, February, March and April). If the 25th falls on a non-business day, rewards will be issued on the next business day.

5. Trades executed between 1st October 2025 and 31st March 2026 (both dates are inclusive) will be qualified for the promotion.
6. All trades placed through online platforms, mobile applications, or call-in services will be considered, except for trades settled via cash settlement, which are excluded.
7. Entry tickets will be calculated on a monthly basis. The top 20 ranking with the highest number of entries will be announced on the 15th of the following month via Phillip Capital Sdn Bhd social media pages and EDM, showing the difference in entries compared to the

preceding rank.

8.
